## I. ROLL CALL AND PLEDGE OF ALLEGIANCE

#### II. APPROVAL OF THIS MEETING'S AGENDA

On motion made by Director Miller and duly seconded by Director Ploetz, the Directors unanimously approved the published agenda, as amended by (i) taking Items VIII.A (Resolution For Continuing Participation In Fire Mitigation Fee Program), IX.B (Promoting Community Awareness) and VIII.B (District Administrative Manager) ahead of order for the convenience of attendees, and (ii) deferring the Closed Session under VIII.B (District Administrative Manager) until the end of the meeting.

- A. <u>District Fire Inspector's Report</u>. In the absence of Fire Inspector, Jeremy Nichols, Deputy Fire Chief, Craig Usher provided results of activities in February 2022, and proposed activities for March 2022.
- B. <u>Fire Marshalls Report</u>. Deputy Fire Chief Craig Usher presented for the Board's review (i) resident communications concerning the seasonal weed abatement program, and (ii) a summary of pending and approved projects for properties located within the District.

Resolution For Continuing Participation In Fire Mitigation Fee Program. (Item VIII.A) Deputy Chief Usher presented for the Board's approval a second reading of a Resolution for the District's continued participation in the Fire Mitigation Fee program. On a motion made by Director Ploetz, and duly seconded by Director Elliott, the board unanimously approved the resolution.

<u>Promoting Community Awareness</u>. (Item IX.B) Deputy Chief Usher reviewed the Department's initiatives to raise public awareness on fire safety.

- C. <u>Fire Department Performance Report</u>. Fire Chief Ned Vander Pol reported on performance by the City of Vista's Fire Department during January 2022.
- D. <u>Fire Chief's Update</u>. Fire Chief Ned Vander Pol reported on matters of interest to the Department and the District.
